- The Tarlac State University through the Special Budget (SB) Fund intends to apply the sum of Two Million One Hundred One Thousand Eight Hundred Fifty pesos (₱ 2,101,850.00) being the Approved Budget for the Contract (ABC) to payments of SUPPLY AND DELIVERY OF OFFICE EQUIPMENT FOR THE COLLEGE OF CRIMINAL JUSTICE EDUCATION Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Tarlac State University now invites bids for the SUPPLY AND DELIVERY OF OFFICE EQUIPMENT FOR THE COLLEGE OF CRIMINAL JUSTICE EDUCATION Delivery of goods is required within thirty (30) calendar days upon issuance of the Notice to Proceed. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project, equivalent to at least fifty percent (50%) of the ABC.
